1. That **no candidate** received a majority of votes for the office of **Mayor**, and that **Steve Carey** and **Robin LeJeune** received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 6, 2020 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
2. That **Ron Scott** received the majority of votes for the office of Councilman for **District #5**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2020.
3. That **Benjamin Hughes** received the majority of votes for the office of Councilman for **District #6**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2020.
