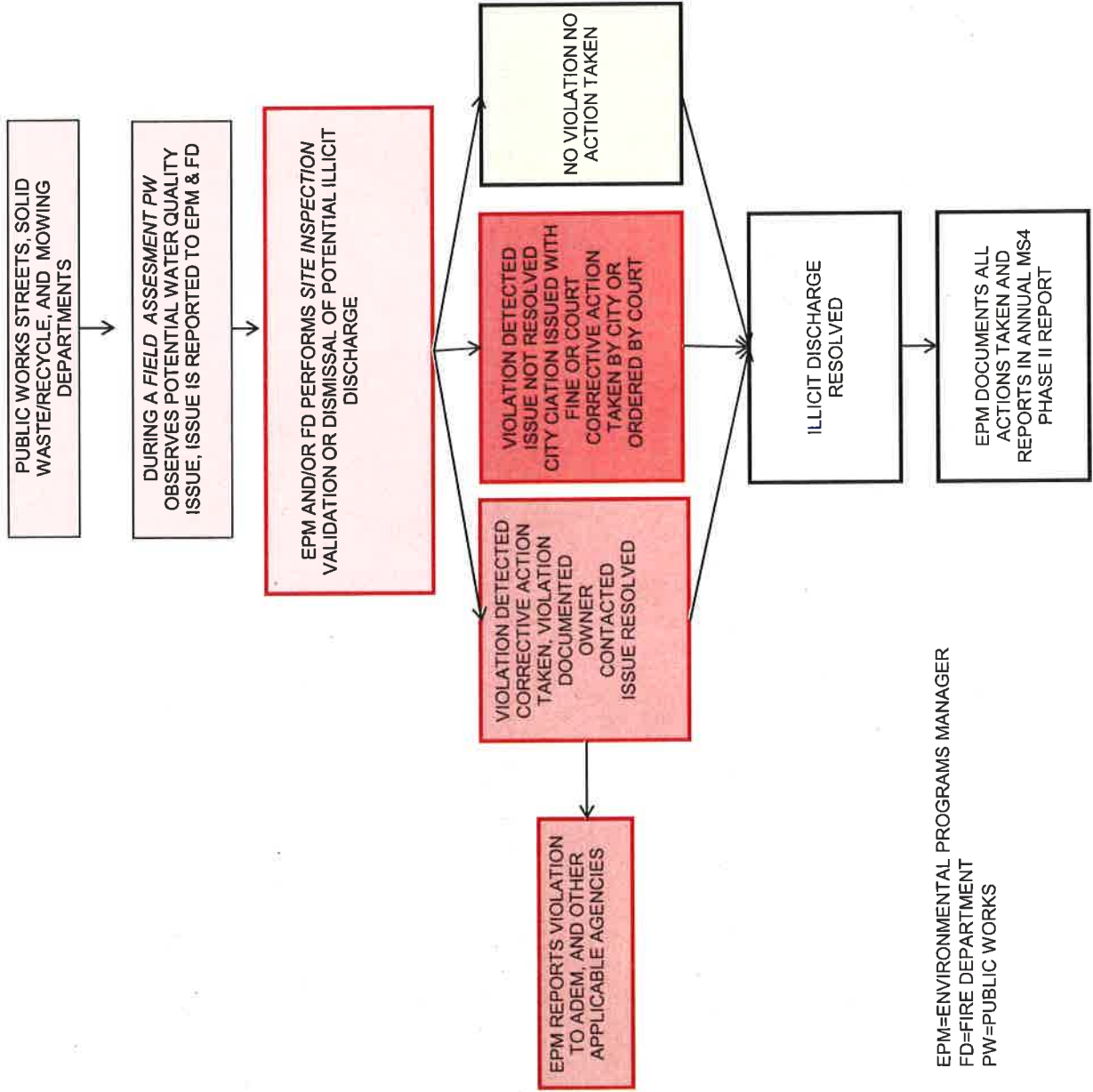
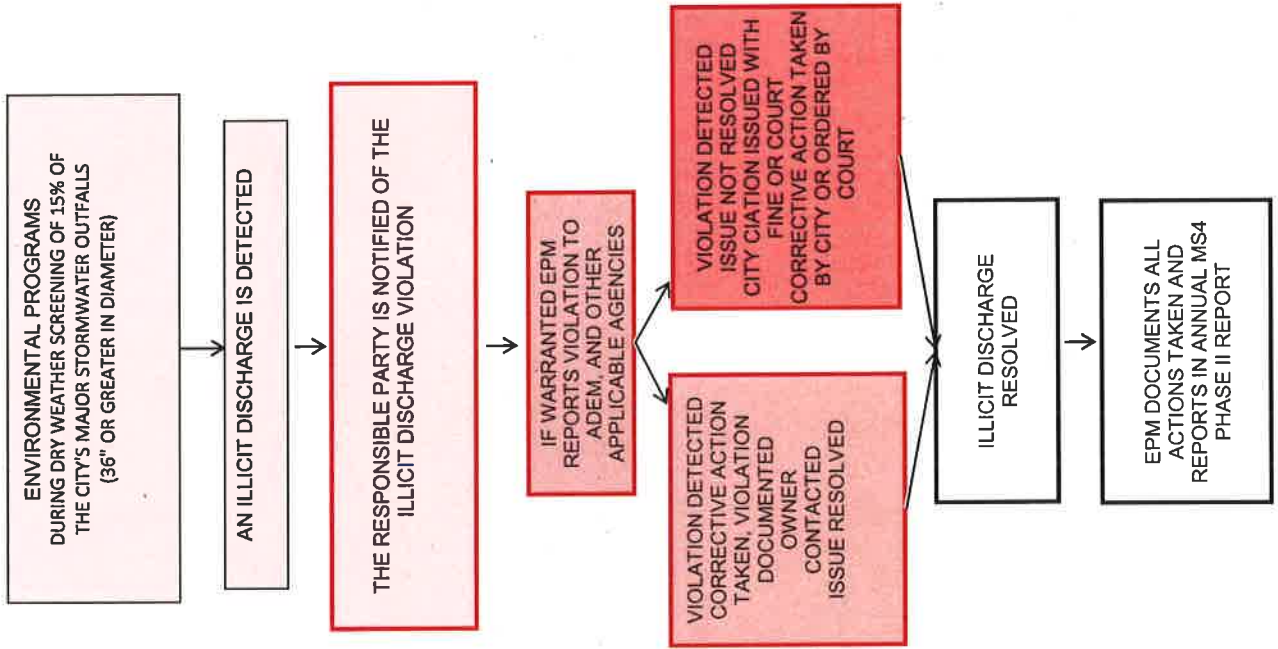

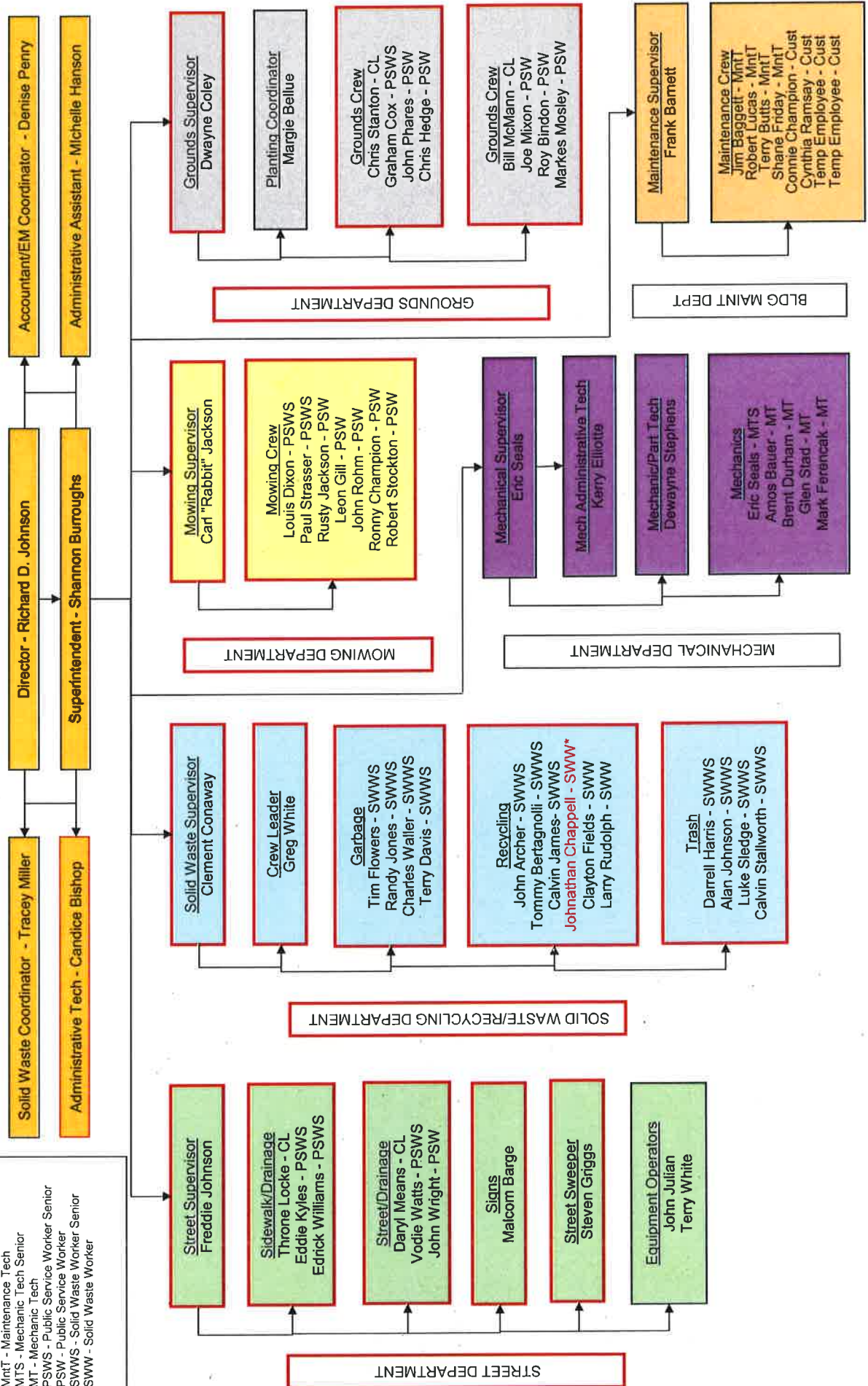

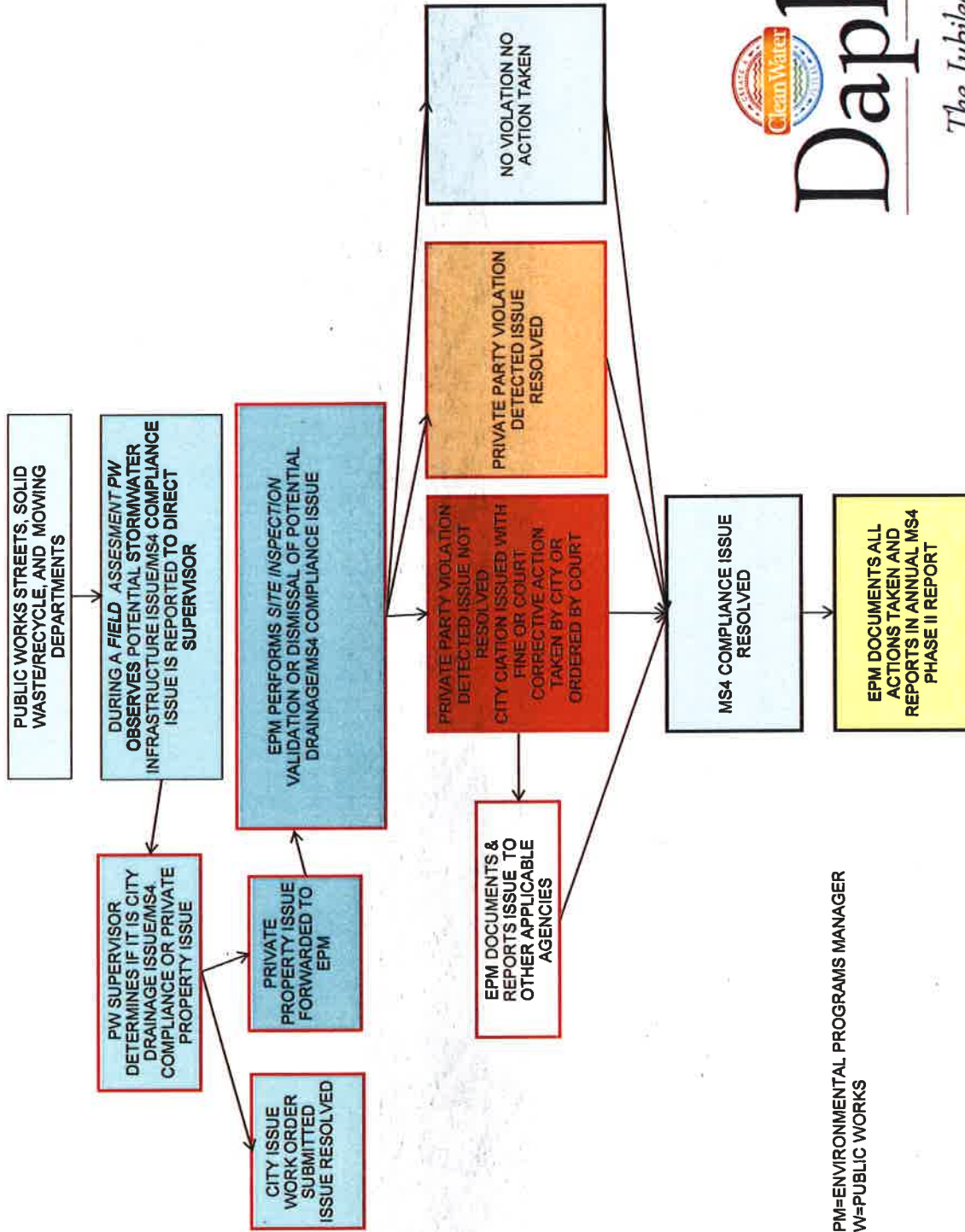

NOTICE TO ALL CONTRACTORS!

The City of Daphne is permitted under Alabama Department of Environmental Management's (ADEM) Municipal Separate Storm Sewer System (MS4) Program. Therefore, the City is responsible for any illicit discharge that enters waterways, drainage ditches, stormwater basins, and/or street inlets. Illicit discharges include but are not limited to paint brush/container wash, concrete wash, and drywall wash non-stormwater discharges, etc.

Precautions to Take:

1. DO NOT WASH ANY CONSTRUCTION PRODUCTS ONTO STREET OR INTO DRAINAGE AREAS; THEY ALL LEAD TO CREEKS.
2. KEEP ALL CONSTRUCTION DEBRIS CONTAINED ONSITE.

City Actions That Can Take Place:

1. STOP WORK CAN BE ISSUED, WITH A \$100 RE-INSPECTION FEE REQUIRED (Ordinance #2008-54).
2. CODE TICKET ISSUED WITH FINE UP TO \$500.00 PLUS COURT COST (Ordinance #2008-54).
3. REFER TO ADEM FOR ENFORCEMENT UP TO \$25,000.00 FINE PER VIOLATION PER DAY (Federal Clean Water Act).
